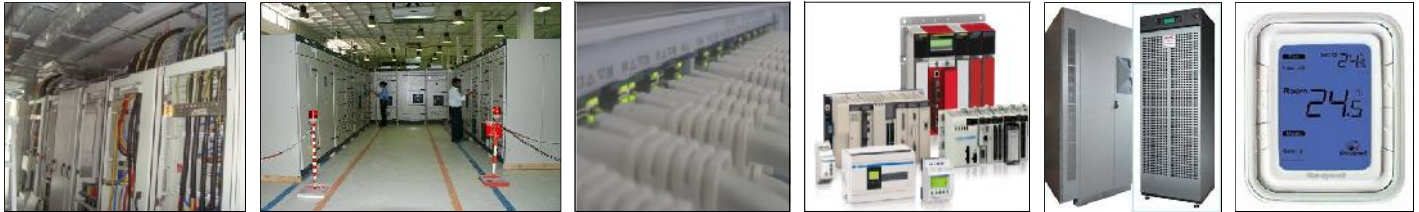

We believe that Quality excellence is inseparable from Health, Safety and Environmental Protection and with that belief, the company is certified for ISO 9001:2015 – Quality,

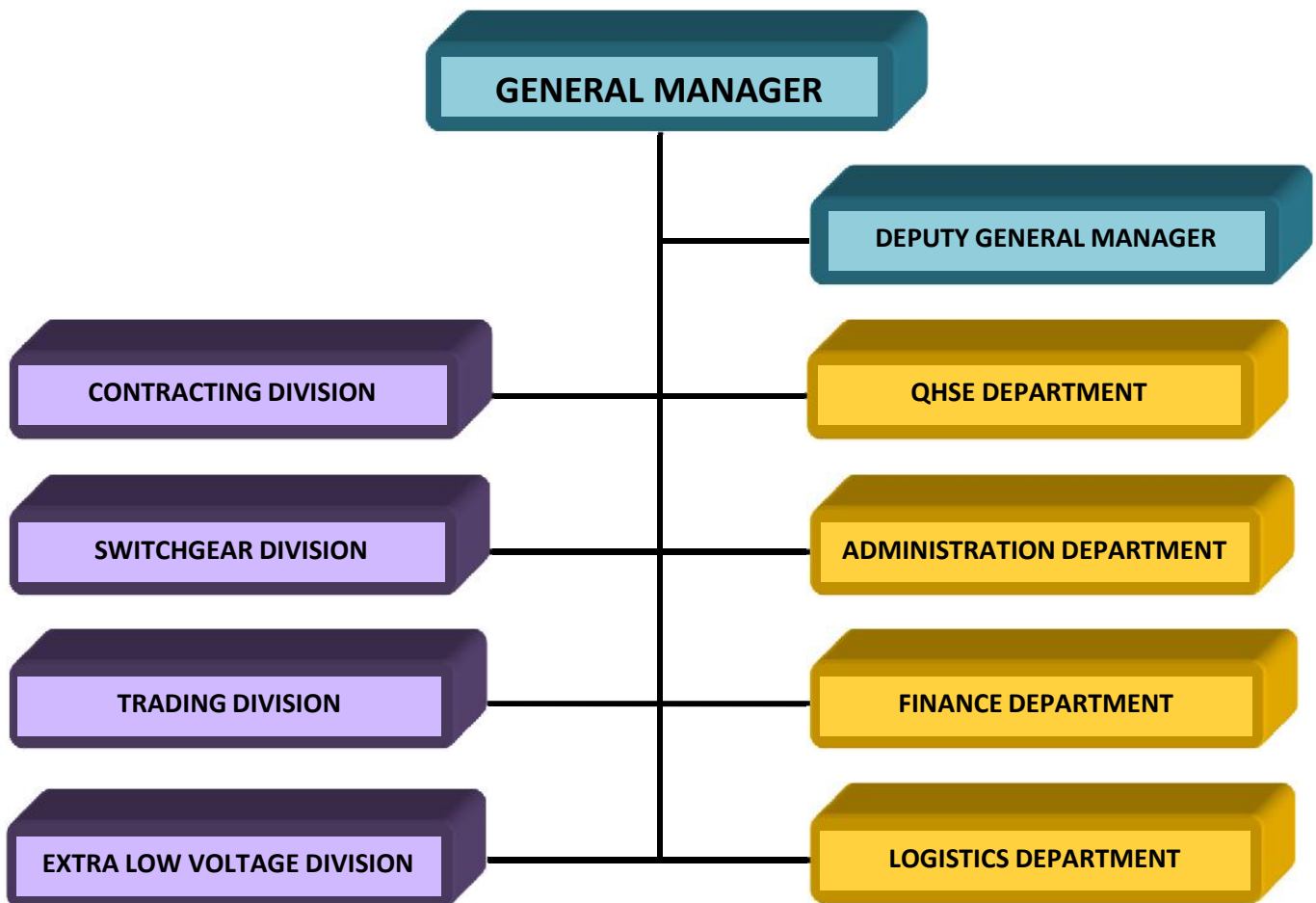


OHSAS 18001:2007 – Occupational Health and Safety and ISO 14001:2015 – Environment.

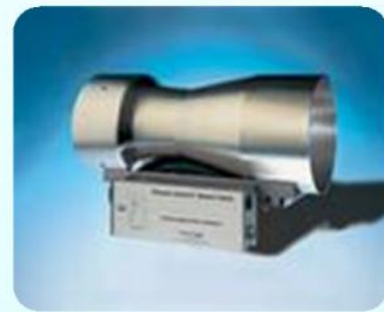

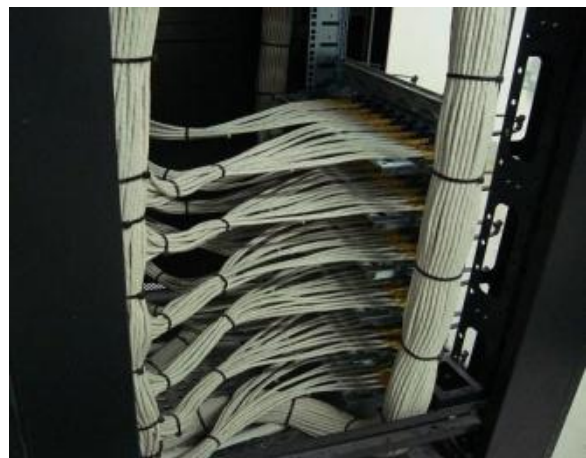
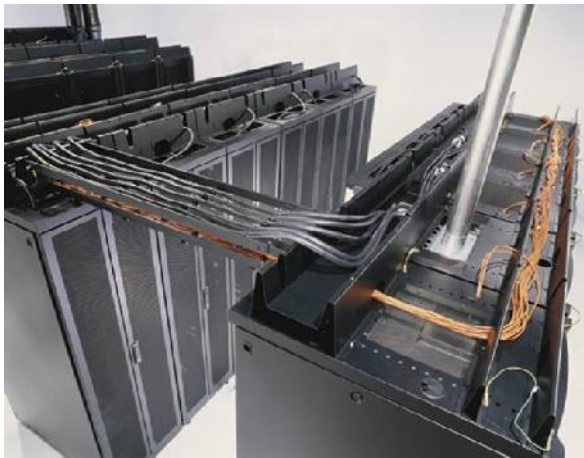




4.0 SCOPE OF ACTIVITIES
